



## GENERAL PRICE LIST

The information given in this list is effective as of November 1, 2021 and is subject to change without notice. The goods and services shown below are those we can provide to our customers. You may choose only those items you desire. Any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items for which you did not specifically ask, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

## PROFESSIONAL SERVICES

### A. BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF ..... \$1,895.00

Our charge includes consultation with the family or responsible party; staff and facilities to respond to initial requests for service; coordinating service plans with the cemetery, crematory and/or other parties involved in the final disposition of the deceased. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.)

### B. ADDITIONAL SERVICES OF FUNERAL DIRECTOR AND STAFF ..... \$500.00

Planning and coordinating all gatherings, memorial services, viewings, visitations and receptions. Coordinating with all participants in all planned events. Production of all printed material and videos. Placement of information and obituaries in newspapers, online websites, social media and both on-premise or off-premise presentation equipment.

### C. EMBALMING..... \$850.00

Except in certain special cases (see requirements of Michigan Law set out below), embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming you usually have the right to choose an arrangement which does not require you to pay for it, such as a direct cremation or immediate burial. The law requires embalming when death was caused by certain infectious diseases or, with very limited exceptions, when the body is not taken to its final destination (such as a cemetery or crematory) within 48 hours.

### D. OTHER PREPARATION OF THE BODY ..... \$500.00

Other preparation of the body includes refrigeration, washing, exterior disinfections, dressing, hair care and cosmetology.

## TRANSPORTATION

### A. Initial transfer of remains to funeral home from place of death within radius of 40 miles ..... \$400.00

### B. Hearse/Funeral Coach within radius of 40 miles ..... \$400.00

### C. Additional Limousine ..... \$400.00

### D. Service/Utility Vehicle..... \$300.00

For the purposes of obtaining death certificate from doctor, permits from county clerk, delivery of flowers and other transportation needed to complete service.

The charge for travel beyond 40 miles for any vehicle listed above is \$3.50 per mile one way.

**FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME..... \$3,200.00**

This charge includes removal of remains, services of the staff, embalming, receptacle for the body, necessary authorizations, and local transportation to the airport. It does not include the services of the staff or the use of the facilities for any visitation and/or rites or ceremonies prior to the forwarding of the body. The cost of other than local transportation in vehicles of the funeral home is \$3.50 per mile one way.

**RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME..... \$900.00**

This charge includes temporary care and custody of the remains, transportation of remains to cemetery or crematory and required services of the staff. It does not include services of the staff or the use of facilities for viewing or for funeral rites/services.

**ANATOMICAL DONATION SERVICE ..... \$2,995.00**

**IMMEDIATE BURIALS .....from \$3095 upwards**

Our charge for an immediate burial without any attendant rites or ceremonies includes; transfer of and care and custody of remains, local transportation to cemetery, necessary services of the staff and authorizations, plus selected casket & sales tax.

- 1. Immediate burial with container provided by purchaser..... \$3,095.00**
- 2. Immediate burial with cloth covered casket..... \$3,895.00**
- 3. Immediate burial with casket selected..... \$3,400 upwards**

**DIRECT CREMATION .....from \$2995.00 upward**

Our charge for a direct cremation without any attendant rites or ceremonies includes; transfer of and care and custody of the remains, local transportation to the crematory, necessary services of the staff, authorizations, cremation plus casket or container selected. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like heavy cardboard or composite materials (with or without outside covering.) The containers we provide are constructed of wood and fiberboard.

## Payment Policy
